- The medium and place of school etc. prescribed by the institution for school permission cannot be changed in future.
- 2) If a school is started at a place other than the place where the permission has been given by the government, the permission given by the government will automatically be considered cancelled.
- 3) As per the provisions of this Act, the permission granted for establishment of schools shall be from the year 2015-16.

- 4) In the academic year 2016-16, classes other than those permitted cannot be started.
- 5) If the management does not start the school within eighteen months from the date of permission, the said permission shall be automatically cancelled.
- 6) It will be mandatory for these new schools granted permission to follow the procedures of the orders issued by the Government from time to time and all the provisions of the Right of Children to Free and Compulsory Education Act 2009 and the Maharashtra Self-financed Schools (Establishment and Regulation) Principal Act 2012.
- 7) It shall be mandatory to put up a board on the facade of the school building for the information of all the public indicating that the new school / class eligible for permission on self-financing basis.
- 8) A school approved under the Maharashtra Self-financing Schools (Establishment and Regulation) Act, 2012 cannot be shifted to another place in future.
- 9) Schools permitted under the Maharashtra Self-Funding Schools (Establishment and Regulation) Act, 2012 will be required to make a separate entry as Self-Funding Schools / Classes while filling information in UDISE.
  - 10) The organization shall be bound to implement the existing prevailing rules of the Government and the rules prescribed by the Government from time to time.
  - 11) Sub-rule 4 (11) of Maharashtra Right of Children to Free and Compulsory Education Rules 2011 must meet the standards.
  - 12) As per Government Decision dated 13th December 2013, the set must be fixed.
  - 13) Teachers should be appointed as per prevailing rules and norms / appropriate action should be taken for appointment of TET qualified teachers.
  - 14) Institute Management and Education Officer (Primary) Z.P. Nashik must be kept in fixed deposit for a period of three years in a nationalized bank.
