





- 1) Providing separate rooms for additional classes.
- 2) Closing the class if the number of students is less.
- 3) Opening the additional class / class will not have an adverse effect on the primary school in the area.
- 4) Completing the backward class backlog at the establishment of the institution.
- 5) The institution has given an undertaking to run the said class / class as a Maharashtra Self-financed school on a permanent basis without subsidy.
- 6) No subsidy can be demanded in the future. And the medium cannot be changed.
- 7) No change can be made in the medium and school location etc. prescribed by the institution for school permission in the future.
- 8) If the school is started at a place other than the place for which permission has been given by the government, the permission given by the government will be automatically considered cancelled.
- 9) It will be mandatory for the new schools granted permission to follow the orders, procedures issued by the government from time to time as well as all the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Self-financed Schools (Establishment and Regulation) Principal Act, 2013.
- 10) It will be mandatory to put up a board in the front of the school building indicating that the new school / class is eligible for permission on self-financing basis for the information of all the public.
- 11) The school approved under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 will not be shifted to another place in future.
- 13) It will be necessary for the schools approved under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 to be separately recorded as self-financing schools / classes while filling the information in UDISE.
- 14) It will be mandatory for the institution to implement the prevailing rules of the government and such rules as the government may prescribe from time to time.
- 15) It is necessary to determine the set as per the government decision dated 13th December 2013.
- 16) Teachers should be appointed as per the prevailing rules and norms / appropriate action should be taken for the appointment of TET qualified teachers.




